Racial Discrimination in Korea Seen in the Islamophobic Incidents, and Solidarity of Human Rights Activists

Background

Since the Yemeni refugee crisis in Jeju Island in 2018, the tendency toward racism and hatred against foreigners, especially against Islamic culture, has become increasingly visible in Korean society. Even in 2021 when the government's decision to bring in Afghan special contributors to Korea, racism and hatred of Islam continued to emerge. The xenophobia that emerged during the COVID-19 almost became a factor to fundamentally neutralize the right to health of everyone living in Korea. The conflict over the construction of a new mosque in Daehyeon-dong, Daegu, which has been in process since 2020, has shown the most extreme hatred and discrimination against foreign and Islamic cultures in Korean society. This also has further spread hatred and discrimination in various areas in our society. Against this backdrop, local activists across the country would share their thoughts on how to respond to such discrimination and hatred, and how to carry out solidarity activities, and discuss possible resistance activities. Furthermore, they would more actively seek a method of solidarity against hatred.
